Allergens: (Ref: 4.9.3.4)	<p>Multiplastics have an Allergen Management Plan. Which has been developed to identify, control, educate and communicate any risk or presence of allergens on site, from raw materials through to finished products.</p> <p>The aim is to minimise or eliminate the risk of contamination to and/or from the packaging and meet legal requirements for labelling in the country of sale.</p> <p>An Allergen Policy (PSQMApp2) is in place which lists out the 14 allergens of concern, as identified in law. This Policy outlines the control of allergens within the site. As part of the hazard and risk analysis the risks from allergen contamination at each stage of the process have been assessed. This has been documented on QCD042 in the hazard analysis which covers all steps on site and assesses any potential risks there are in the delivery of contaminated raw materials.</p> <p>Our purchased raw materials do not contain any known allergens. There are no maintenance consumables used by staff on site which contain allergens eg nut / soya oils. Cleaning procedures are in place for all areas as required for good hygiene control (WI15).</p> <p>Segregation: As there are no identified allergens in any raw material or finished product on site there is no requirement for any segregation of materials as there is no risk of cross-contamination.</p> <p>Labelling: There are no allergens in any product supplied by Multiplastics (Europe) Ltd, therefore there is no allergen labelling required.</p> <p>The allergen management plan shall be reviewed annually and when there is a change to raw materials, suppliers, the manufacturing process, machinery and equipment or if there is a change to cleaning practices and procedures.</p>
